This privacy statement relates to the following process:

Course Absence Reporting

Your information will be used for the following purpose:

To record and administer your absence from study, including any bursary adjustments or reporting requirements.

Our legal reason for using the data is:

Processing is necessary for the performance of a contract, that being your student contract with the college and the college's need to record and monitor absence levels. Some extra data may be required to administer the contract associated with any bursary payments you may receive.

The processing is necessary for legal obligations on Argyll College; that being its Duty of Care, requirements of the Health and Safety Act and obligations under Further and Higher Education Scotland Act (terms and conditions of funding as set by the SFC).

The data collected may include special category (sensitive) data – in this case, health data. Where health data is collected our processing condition is:

Processing of the data is necessary for a matter of substantial public interest; that being mitigating the effects of the Coronavirus epidemic on students, especially the avoidance of undue financial disadvantage. The processing function is conferred on the college by law; that being the Further and Higher Education (Scotland) Act, terms of funding dictated in accordance with that act, and appropriate statutory guidance relating to the Coronavirus epidemic issued by the Scottish Funding Council.

If you were to withhold the personal information we require for this process, the consequences would be:

Your absence will not be correctly recorded which may result in unexpected bursary or funding adjustments and may lead to the Student Absence Monitor Policy actions being engaged.

Your data will, or may, be shared with the following recipients or categories of recipient:

Your data may be shared with the Scottish Funding Council (SFC) to allow them to allocate appropriate funding to colleges in line with Scottish Government strategies and their statutory duties. Student name, ID number and absence record may be shared.

For HE students:

Your data will not be shared with SFC

Your data will be retained for the following length of time:

Your data is held until six years from the end of the academic year in which it is collected.

The following rights are rights of data subjects:
